

## Condition rental

### PREVENTIVE:

On application of the client the office formulates preventive of cost of the services in base to the data furnished by the same.

Such estimates have indicative character and the amount of the invoice, you/he/she will be calculated on the real km.

I crossed in base to the present rates and conditions.

### RATES:

THEY UNDERSTAND: motorway tolls in Italy and gas-oil.

They don't Understand: IVA (if due), ticket ZTL (zones to limited traffic), parking lot, cartoons, tolls highways to the foreign countries, tolls and individual taxes of the travellers in Italy and to the foreign countries, foreign IVA, taxes bus for the foreign countries, ferries, piercing, bridges and trains shuttle for the bus and everything how much not specified under the voice the rates "they understand."

- ✚ The firm anticipates the expenses for highway to the foreign countries, ZTL, parking lot, ferries, transit piercing, customs and various on behalf of the clients, the same will subsequently be debited in invoice.

- ✚ Il payment of the invoices must have effected, different accords excepted I taken, to sight invoice and as expectation from the D.L.vo 9.10.2002 ns. 231, with debit of the anticipated affairs from the art. 5, in case of delayed payment.

### ROOM AND BOARD DRIVER / THE FOR THE TRIPS MORE DAYS:

The relative expenses are to load of the Buyer; if is not directly paid on the spot from the Buyer, you/they will be bewitched for the whole amount.

### SUPPLEMENTS :

1 SECOND DRIVER: € 160,00 a day, besides the possible expenses for the return in the deposit of departure in case of partial use.

2 NIGHTTIME GUIDE: the services must finish within the hours 22.00. Over such time, a supplement must be corresponded of € 30,00 an hour thin to a maximum of 2 hours. Old these 2 hours, a further equal rate will be applied to € 20000.

### CROSSED TO EMPTY:

The km crossed to empty, different indication excepted, the Buyer's load you/they are counted to.

### CANCELLED OF CONFIRMED SERVICES:

For the service abdicated later happened confirmation you/he/she will be debited to the buyer € 150,00, what reimbursement of the damage immediately for the missed use of the bus; if such renouncement is effected the day when you/he/she must unwind the service, the reimbursement will be of € 200,00 anymore the km of the possible run to empty of the bus

### THE PERSONNEL'S REQUISITE:

The buses are exclusively conducted from dependent of the firm towards which you/they are carried out all the Social Security and relief obligations; the drivers are provided some professional documentation of law. In the employment of the travelling personnel the firm applies the in force normative national and European in theme of regulation of the daily times of guide and rest of the drivers turned not to services of line; particularly it is anticipated that:1. the general duration of guide must not overcome the 9 daily hours with maximum 12 hours of availability;2. the continuous duration of guide must not overcome the 4 hours and 30' after that you/he/she must have respected a break of 45', fractions in more interruptions than at least 15'; how expectation from the Rule Us 15/03/2006 ns. 561 - us 3821/85. Us 2135/98. Us 3820/85 3. for the trips that ask for superior periods of guide to 9 hours, the firm uses two drivers.

### REQUISITE OF THE VEHICLE:

All the used buses own the anticipated title to the registration and in order with the dispositions in force in subject of annual revision. Besides the firm foresees cycles of preventive maintenance to lilt

#### **FORCED INTERRUPTION OF THE SERVICE:**

In case of technical breakdown of the vehicle, the firm guarantees a timely intervention with the purpose to limit at the most the uneasiness of the travellers through the activation of his/her own structure or of the organizations settled for the interventions of reparation or substitution of the vehicle.

#### **RESPONSIBILITY:**

All the buses are insured for the consequential risks from the road circulation to the senses of the law 990/69 with primary institute insurance with maximal only of € 10.500.000.

#### **LOST OBJECTS:**
